## **Certification Tips - Synopsis of the Three PMI Professional Certifications**

#### The <u>Certified Associate in Project Management</u> (CAPM<sup>®</sup>) Credential

A sort of associate PMP certification. Meant for the project manager that is learning on-the-job, perhaps under other Project Managers, but with limited formal PM training and experience.

#### The Project Management Professional (PMP®) Credential

The standard-bearer of project management certifications. The primary certification for working Project Managers. Thus the highest number of certifications awarded, but not because the process is easy or inexpensive.

#### The Program Management Professional (PgMP<sup>SM</sup>) Credential

Meant for the manager of Program Managers or leaders of a corporate Project Management Office (PMO) and launched October 1, 2007.

#### **Course Description:**

**Proactive Project Risk Management:** This course examines project risks from both a top-down and bottom-up perspective using a proven five-step risk management process. Participants will learn how to evaluate and respond to risk at the project and task levels using effective tools and a highly regarded assessment model. Control multiple risks using mitigation and contingency strategies. 4. Overcome psychological barriers to risk in stakeholders and team members. 5.
