



## **Our Next Chapter Meeting - April 14th**

**Program:** The program for the April 14th meeting is a presentation entitled **"Black Bag of Tricks"**, presented by Terry Knecht.

**About the Program:** There are very good and detailed road maps on how to manage a project. There is PMBOK. There is all of the theory. Beyond these canned solutions there are a number of techniques and structures that have been tested by the counterattacks of adversity that provide the practitioner the advantage in the struggle for a successful project. Terry will cover very specific environmental structures (things that should exist before the project starts), how to position the game board for advantage, and effective execution strategies.

About the Speaker: Terry Knecht (MBA, CISSP, PMP) is currently Assistant Vice President, Chief Information Officer for The University of Iowa Foundation. He led a total reimplementation of all technology at both Lexi and UP&UP. The project to develop a multisite telemarketing software solution at Lexi International resulted in an award for the Visionary Use of Information Technology in the Field of Business by the Smithsonian Institute ComputerWorld.

## **President's Corner**

## **Project Management – Communication during Crisis**

Managing projects that are considered critical to an organization's success bears many risks and uncertainties, project managers know this all too well. Even the best plan can be thwarted by unexpected economic or political developments, or simply by individual mistakes or bad planning. This happens every day and most often can be fixed internally with simple upfront planning. Sometimes, however, a "problem" can develop into a "crisis" which will trigger a quick response with limited planning time, necessitating a need for quick action.

Project managers are usually the first to notice a potential crisis. And in a crisis, time is of the essence. Project managers need to be aware of this and need to know how to react during a crisis. Unfortunately, there is no specific recipe for managing crisis. Each crisis comes with its own flavor.

#### Preparation, Response, Recovery

The three phases of crisis management: preparation, response and recovery. First off, it is essential to include crisis management, communication rules in every individual project plan and to pre-select appropriate responsible teams/ individuals for managing the crisis when it arises. The most immediate goal here is to regain control of a situation that, by definition, is rapidly becoming difficult to manage. It is imperative to properly assess the severity of the potential crisis and gather all the facts available before taking appropriate action.

Effective communication during crisis management is of paramount importance. Multiple and timely communication to all stakeholders is critical during the crisis. While additional stakeholders may be involved in resolving a crisis, project managers are still responsible for the overall resolution. Loosing control o the project ('Ship') could jeopardize the credibility of the project manager.

## Crisis communication checklist for project managers:

#### Preparation phase:

- Consider crisis communications details for each project plan
- Determine who will be in charge of initial communication
- Media training for designated project spokespeople
- Prepare lists of internal and external audiences (who must know what?)

#### **Response phase:**

- Assess situation and risk level (objective and subjective impact?)
- Gather all the available facts before speaking to media
- Inform internal audiences, i.e. management and PR department
- Craft an effective first-responder message
- Avoid "no comment" responses

#### **Recovery phase:**

- Gather positive news to offset negative reporting
- Assist PR department and management with information on problem resolution
- Assure project stakeholders that operations are back to normal

Never underestimate the importance of a strong network. If you were a company that wanted to be known for the quality of service you provide, it would be tough to cut corners on your network. Many of the same principles apply when looking at establishing a strong professional social network.
