Leading an organization can be challenging, even when times are good. When times are troubled, it is even more important for leaders to come center stage and provide direction and inspiration.

### **Delegating Can Be Hard To Do!**

You have an assignment due in a few days. The right thing to do would be to delegate this assignment to Employee #1; however, by the time you explain the assignment to Employee #1, then proofread her outcome, then allow her time to make additional changes, it may be pushing close to the due date. It's just so tempting to sit down and do it yourself, right? Well sure it is! Then the assignment will clearly be done to your liking and turned in on time.

As tempting as this may be, in the long run this self-satisfying immediate approach does not teach Employee #1 how to perform this new assignment nor is it allowing you freedom to perform other tasks. Yes, delegating is initially more time consuming, takes patience, and face it, Employee #1 will never quite mimic how you would do it. So why delegate?

Eventually you will train Employee #1 to perform the assignment to meet your expectations. Remember, it's the outcome that you should be concerned with, not the exact path that the employee took to get there. Once Employee #1 has mastered this task, she is now ready to add additional tasks. Just think of the work that you can assign her now!

Delegating allows your employees to build their skill sets. Taking the time to train them shows them that you are interested in their work and that you are willing to help guide them to meet your expectations. Delegating also allows you to concentrate on the larger issues at hand.

So, if you find yourself working too many hours, or you have a long line of people outside of your office waiting to speak to you, or you don't believe that your workplace can survive without you, this may be an indication that you too need to learn to delegate!

### Some Tips & Tricks for Taking the PMP Exam

There are loads of great resources available to help you prepare for the PMP Exam. The following are just some of the many valuable suggestions from Rita Mulcahy's *PMP Exam Prep*, *Rita's Course in a Book for Passing the PMP Exam*, fifth edition. I used this book when studying for my exam and it proved to be quite helpful!

- Understand the material cold. Do not assume the exam tests memorization; it tests knowledge, application, and analysis.
- Have real-world experience using all the major project management techniques.
- Read the *PMBOK*® *Guide* (at least three times, cover-to-cover)
- Practice being able to pick an answer from what appears to be two or three right answers.
- Get used to the idea that there will be questions you cannot answer.
- Answer the questions from PMI's perspective, not the perspective you have acquired from your life experience.
- One of the main reasons people answer incorrectly is because they do not read all four choices.
- There may be more than one "correct" answer to each question, but only one "BEST" answer. Practice looking for the BEST answer.
- Watch out for choices that are true statements but not the answer to the question.
- Watch out for choices that contain common project management errors. They are intentionally there to determine if you really know project management.
- When a question asks you to fill in a blank space, the correct answer may not be grammatically correct when inserted in the sentence.
- As soon as you are given scratch paper when you arrive at the exam, write down anything you were having trouble remembering. This will free up your mind to handle questions once the information you are concerned about is written down.
- Take the night off before the exam to do something relaxing and get a little extra sleep. DO NOT STUDY! You will need time to process all you have learned so you can remember it when you take the exam.
- Use all the exam time. Do not leave early unless you have reviewed each question twice.
- Remember that it is OK to change your answer as long as you have a good reason.
- Create a test-taking plan and stick to it. This may mean, "I will take a ten minute break after every 50 questions because I get tired quickly" or "I will answer all the questions as quickly as possible and then take a break and review my answers."

Remember: studying for the exam requires more than just the PMBOK! As a PMI member, there are hundreds of books available to you free of charge via the "eReads and Reference" section of the PMI website. Looking for more information on Rita Mulcahy's books and courses? Go to www.rmcproject.com.
