# **President's Corner**

# You Spoke, We're Listening!

Last month, we reported on the Project Management Institute's (PMI's) commitment to serving its valued stakeholders as well as the broader project management profession. As part of PMI's on-going efforts, it conducts an annual survey to measure chapter members' satisfaction.

Sixty-six (66) of our current 306 chapter members responded to the survey, resulting in a response rate of about 22%. While we would have loved to see a 100% response rate, 22% is only slightly lower than industry averages for electronic survey responses (<u>www.supersurvey.com</u>). We learned the following from those who responded:

- The majority of our chapter members (39%) have been members between 2-5 years.
- The primary reason members joined our chapter is to network with other project managers (33% of respondents).
- Regarding overall satisfaction with their chapter membership, respondents indicated:
  - Very satisfied 17%
  - Somewhat satisfied 47%
  - Neither satisfied or dissatisfied 23%
  - Somewhat dissatisfied 10%
  - Very dissatisfied 3%
- Considering the benefits received from the chapter in relation to the price, respondents indicated the overall value of chapter membership as:
  - Excellent 20%
  - Very Good 30%
  - o Good 24%
  - o Fair 20%
  - Poor 6%

In general, I am pleased with the results of the survey. You can view the complete survey results by going to our website at <u>www.pmieasterniowa.org</u> and scrolling down the home page to Announcements.

There were a couple of survey comments that I would like to discuss, and I encourage you to provide additional feedback on these comments to help us serve you better.

- E-mail: On this survey and prior surveys, we have gotten comments to stop sending junk e-mail and spam.
  - The Leadership team works hard to limit the number of outbound e-mails to no more than 2-3 per month. Typically, we send one message at the beginning of the month to announce the publication of the monthly newsletter and the monthly chapter meeting details. We will send a second reminder e-mail a few days before the registration cut-off for the chapter meeting. And, finally, meeting attendees will generally receive a short e-mail following the meeting to complete a survey. Occasionally, for special events such as our Professional Development Day or for other critical announcements, we might do an additional e-mail to the membership.
  - These are the only types of outbound e-mail distributed by our chapter. If you have examples of other junk e-mail or spam that you believe are coming from our chapter, please forward the example to me at <a href="mailto:president@pmieasterniowa.org">president@pmieasterniowa.org</a> and we will research it.
  - You might be receiving e-mail from PMI Global. Look at your profile on <u>www.pmi.org</u>. Under Communication Preferences, you can "opt out" of e-mail promotional messages about PMI products, services, and events. You can also choose to be excluded from third party mailing lists. Changing your preferences here will not disrupt messages you receive directly from the PMI Eastern Iowa Chapter.

- You have the option to "unsubscribe" from the PMI Eastern Iowa e-mail distribution list at any time by clicking the embedded link at the bottom of our e-mail messages.
- Not receiving chapter communications: Our chapter distribution list is built from the e-mail address that you have provided to PMI Global. If you need to change your e-mail address, you must go to your profile page at <u>www.pmi.org</u> and make necessary changes. When we download our member data report each month from PMI Global, changes made to your profile (contact information, company name, etc.) will be updated in our chapter database.
- Providing input on chapter meeting topics: We encourage your input on topics for chapter meetings and for speakers. The survey sent to attendees following monthly meetings includes a question about future topics or speakers, and we do use this information to schedule relevant topics and speakers for our meetings. In the past year, we have also networked with the Quad Cities and Central Iowa chapters to get speaker names and topics that were successful with their chapters. Please send any ideas you have for speakers or topics to programs@pmieasterniowa.org. It is a challenge to find available and engaging speakers each month, so your input is always welcome.
- Meeting logistics: With a membership exceeding 300 individuals from the Waterloo, Cedar Rapids, and Iowa City areas, it is a difficult to find a time and place that will accommodate everyone's hectic schedules. Based on previous survey feedback, we made it a goal to offer three chapter meetings in the Iowa City/Coralville area in 2012. We have two more meetings scheduled in Coralville this year in August and October. We are looking to continue or expand this in 2012. Our chapter meeting prices are also set to offset the costs of room rental, equipment charges, and food and beverages. We strive to get the best value for the membership by negotiating rates that are inclusive of all charges. Based on prior year surveys, over 75% of respondents prefer morning chapter meetings, so we plan to continue with this schedule for the near future.
- Leadership/Volunteers: As you know from our repeated calls for volunteers earlier in the year, it took us a few months to get to full strength on our leadership team with all director positions filled. Speaking at least for myself, it is sometimes a challenge to balance my full-time job, family/personal responsibilities, and volunteer work for our chapter. I am grateful for all of our volunteers and appreciate their efforts to support our chapter goals. Soon, we will begin work on the slate of candidates for the 2013 elections. Anyone who has an interest in running for an office or serving as a director can e-mail me at president@pmieasterniowa.org, and I will pass your name along to our nominating committee. The most important qualifications for serving the chapter are to be a chapter member, have a desire to advance the goals of the chapter and PMI, and be willing to volunteer up to 10 hours per month. This is a great way to earn professional development units (PDUs), build up your resume, and expand your professional network. In addition, if you have had a negative experience at a chapter event or with a member of the leadership team, I welcome your specific feedback so that I can address the situation.

There is always room for our chapter to improve and I do think we are doing pretty well. When I recently attended the Region 2 meeting in Minneapolis, I discovered that for a smaller-sized chapter, we have been innovative with what we can do on a limited budget. Again, I encourage each of you to provide us input on what you need from the chapter.

## Snapped Back to "Reality"

Recently I was invited to attend an afternoon conference, free of charge, courtesy of my employer (which for me - and maybe for you - is very rare). Of course I jumped at the opportunity to go attend the 3-hour session, maybe pick up a tidbit of wisdom or two, but generally have an elusive "easy afternoon." I was excited as the day approached, anticipating an afternoon of calm and fun, with the speaker, Cy Wakeman: a former HR employee, author of "Reality-Based Leadership," and local Midwesterner.



#### Well, do you want to know what really happened?

I'll tell you what happened: I got my butt kicked, that's what really happened. I was snapped back to reality.

One of the most powerful messages the speaker delivered was that we cannot change our reality in our workplace, yet we try to do it all the time, or waste energy on promulgating why decisions made by our leadership are dumb. Then we wallow in the senselessness of the stupidity of the supposed dumb decisions and drag other people into our drama. But, do we know for a fact that these decisions were bad? No, not personally as fact – we rationalize it in our mind, or conclude based on feeling or emotion that since the decision is different from ours, it's bad, and we end up making up our own stories about it. Basically, this is a waste of time and energy, and if you are a leader, you should never engage in it. I had to stop dead in my tracks, since earlier that day, I had whined incessantly about just that kind of situation. Don't do it. Don't fall into the drama trap.

So how do you deal with the inner turmoil of living with your reality, if you don't like your reality? You have to change the way you look at it. You need to see your circumstances differently, not hope to change it. Have we all dealt with a dumb decision in the past? Of course! But the decision was already made; now what the company (and your boss) needs for you to do is execute it, and what the company needs are team players and people who will get things done.

Speaking and reacting only with facts and then outlining risks that come along with the foregone decision will save a lot of energy. It takes all of the emotion and drama out of it. And, the communication of risks are key – not only so the scope and tradeoffs are understood by everyone involved, but you are covered as well, as you thought things through and made people aware of potential issues. Any task or project can be executed – it's just a matter of how much scope or money will realistically align with that and what are the associated risks.

The next day I started working within my new reality and the guidelines of using facts and risks and I was much more energized (and productive) as I went about solving problems. - 2. Job should be seeking individuals with project management or related skills.

Note that all postings are subject to review and removal by PMI EIC.

# To Post a Job Opening

- Login to our website at <u>www.pmieasterniowa.org</u>. All postings for open positions must be self-reported. The PMI EIC will not enter open positions on behalf of third parties.
- Select Career Development > Jobs > Post a Job.
- Enter information about the position in the appropriate fields. Note that fields marked with an asterisk are required. A job posting will not be saved if any of these fields are missing.
- Enter an expiration date for the posting. Note that the default expiration date is six months from the posting date. If the position is filled, it is the poster's responsibility to remove the posting from the website.
- Click Go to Step 2: Review.
- Review the position information. If edits are needed, click go back and change it.
- Click **Submit this Ad** if everything is correct. The posting will immediately be available to website visitors.

- Select Career Development > Jobs > View Jobs.
- Click the appropriate link under the **Job** listing for posted positions.
- Review the information under **How to Apply** about submitting an application/resume for the position.
