Are you one of the few PMs that wish to get their PMP certification? Do it soon. Do it now, because starting August 1, 2013, candidates taking the PMP will be tested on the Fifth Edition of the PMBOK. This revised version has the following changes:

- A 10th Knowledge Area has been added; Project Stakeholder Management expands upon the importance of appropriately engaging project stakeholders in key decisions and activities.
- Project data information and information flow have been redefined to bring greater consistency and be more aligned with the Data, Information, Knowledge and Wisdom (DIKW) model used in the field of Knowledge Management.
- Four new planning processes have been added: Plan Scope Management, Plan Schedule Management, Plan Cost Management and Plan Stakeholder Management: These were created to reinforce the concept that each of the subsidiary plans are integrated through the overall project management plan.

Coming back to our Eastern Iowa community, I look forward to seeing familiar old faces and many new ones at the Chapter Meeting on February 14.

I do, however, express one caution before you come to the meeting – Don't forget that Valentine Day card!

2012 Annual Report

Each year, the chapter publishes an annual report, which is our official notification to our chapter members about the Eastern Iowa Chapter's prior year successes, membership status, and fiscal health. The 2012 annual report has been posted to the chapter website. You can locate the report by clicking on Publications > Annual Report.

I encourage all members to take a few moments to review this report. The Eastern Iowa Chapter met its fiscal objectives for 2012 and finished the year by adding \$1,352.78 to our reserves. Our goal each year is to manage an operating budget that meets our annual expenses through our annual revenues. Our two primary sources of revenue are the Professional Development Day (PDD) and your membership dues. Our standard operating expenses include speaker fees for the PDD and chapter meetings, insurance, our chapter scholarship endowment payment, chapter website fees, registration and travel expenses for selected chapter leaders to attend regional and national events, and meeting and event expenses (food, beverages, room rental, etc.).

It is also important to note that PMI Global provides guidance to chapters that it is a best practice for chapters to maintain a reserve fund that is equal to two years' of operating expenses. Our chapter has successfully maintained this reserve fund for several years without needing to access the fund to support annual operating expenses.

We have noticed a slight drop in chapter membership for the past couple of years, which has had a negative impact on our revenue. While we assume that some of the reduction may be due in part to the economic downturn of the past couple of years, we are cognizant of the need to continue to add value for our members. The leadership team will focus on this in 2013.

What a Difference a Year Makes

I have been thinking about this saying—what a difference a year makes—a lot lately. You see, last February, I was not active in PMI's Eastern Iowa Chapter and I was not a PMP. Fast forward to this February and I am the Chapter's Director of Marketing and a PMP in good standing. In 2012, I was able to actively participate in the Professional Development Day, facilitate one of the chapter meetings, and get to know the wonderful group of people who belong to this chapter. Through a combination of chapter activities and continuous learning, I was able to earn enough PDUs to recertify my PMP through 2018. What a difference a year makes!

We all have unique journeys that we take to achieve the PMP certification. If you had asked me two years ago if I was going to be a PMP, I would have answered with a resounding no. Why? I was done with school! It took me six years to complete my Ph.D. in Knowledge Management. When I finally graduated, I vowed that I was done with school, test taking, studying, etc. Even though I understood the value of the PMP certification and certainly respected the PMPs with whom I worked, I had no interest in being part of PMI. It seems the universe had other plans.

In June 2011, I was bid on a government contract that required its project manager to be PMP certified. I was extremely interested in the position, and that meant getting my PMP as soon as possible. I completed the PMP application and began to look for a boot camp through one of PMI's registered education providers. I was nervous because I was being asked to work on the bid and squeeze in a boot camp. Oh, and I was being asked to take and pass the exam as soon as possible! Unfortunately, the government agency decided to rescind its request for proposal. Fortunately, that took the pressure off of me to go to a boot camp and take and pass the exam in the June 2011 timeframe. As soon as that pressure was off, I promptly stopped thinking of all things PMP-related. Then in January 2012, the clock started ticking again.

I decided to sign up for a boot camp and go forward with the PMP process when I realized in January 2012 that my application was going to expire within the next few months. I signed up for a boot camp sponsored by PMstudy and found myself driving to Kansas City, MO last February. I told no one. Well, I told my boss, but I did not tell any co-workers. I went through the boot camp and I took the exam the following week in Iowa City, IA. The exam was tough. I do not usually consider myself as someone who has test taking anxiety, but I was a wreck. I could not decide if I wanted to cry or throw-up during the entire time I was taking the exam. When the "you passed" message flashed up on the screen, I was very happy and relieved. I promptly went to work and told PMI Eastern Iowa Chapter Past President Carol Scherrman that I was now a PMP. It should come as no surprise that she encouraged me to become active in the chapter.

I am looking forward to our year together. What a difference a year makes!
